



BINGO BLACKOUT CONTEST RULES AND REGULATIONS

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. Contest is void where prohibited or otherwise restricted by law.

CONTEST/GAME: The first day of each month will start a new “Black Out Bingo” game. Each Wednesday through Sunday at 3pm (PST) we will spin and draw three (3) numbers. Numbers will be posted on Sponsors home page of the website and Facebook Page. Numbers will accumulate each day until a “Black Out Bingo” is announced by the first winning participant of each month. Each Bingo sheet contains three (3) individual Bingo cards and are available in the winery tasting room, one sheet per month per person. For every three (3) bottles purchased throughout the month participants will receive one (1) additional Bingo Sheet. Example, if you purchase an additional twelve (12) bottles the participant would receive four (4) Bingo Sheets. Participants may join in on the monthly game at any point during the month by visiting the Sponsor Website or Facebook Page to obtain the previously drawn numbers for that month.

SUBMISSION OF WINNING “BLACK OUT” INSTRUCTIONS: Once you have a completed “Black Out” Bingo Card you must take a picture of both you and your winning card (making sure that the bingo card numbers are clearly visible to be verified. The first winning “Black Out” card and participant will be the monthly winner, only one winner per month.

ELIGIBILITY: The Oak Knoll Winery (SPONSOR) “BLACKOUT BINGO!” game is open only to persons who, as of date of entry, are legal resident of one of the fifty (50) United States or the District of Columbia, at least 21 years of age or older at the time of entry. Employees, retirees, and agents of Oak Knoll Winery (including their families and persons living in their households), and each of their distributors, wholesalers and retailers, and member of such employees, are not eligible to enter or wine. For purposes of this Promotion, “immediate family members” means parents, spouses, children, siblings, in-laws, or grandparents.

HOW AND WHEN TO ENTER: Contest begins at 12:00 a.m. PT on the first day of each month and ends at 11:59 p.m. on the last day of each month (“Promotion Period”).

PRIZE AND CONDITIONS FOR AWARDING PRIZE: Winner must meet all eligibility requirements. In the event Winner is deemed ineligible, or is not available to claim prize the very next “Black Out” winning card will be deemed the winner of the month.

Prizes: Only one (1) \$100.00 gift card prize awarded to the first Blackout winner each month. Total Prize Structure Approximate Retail Value (“ARV”): \$100.00. Winner is responsible for all applicable taxes incurred by winning the Prize. All Prizes are non-transferable and non-assignable, except at Sponsor’s sole discretion.

ODDS: Odds of winning depend upon the number of eligible Bingo cards played during each month Promotion Period.
